<p>CLINIC EXPENSES</p> <p>*(assumes Embryo Creation is required)</p> <p>Variables:</p> <ol style="list-style-type: none">1. Canadian vs. U.S. Clinic2. Egg Retrieval Package included or not3. Multiple transfers included or not <p>Very important to understand Clinic policies and cost sheets</p>	<p>Canadian Clinic: \$30,000 to \$55,000 <u>Guarantee program</u></p> <p>U.S. Clinic: Can be more expensive</p> <p>If already have Embryos and use a Canadian Clinic considerably less expensive</p> <p>\$2000 in shipping costs + \$5,000 to \$7,000 per transfer</p>

<p>EGG DONOR EXPENSES</p> <p>This estimate INCLUDES:</p> <ul style="list-style-type: none"> - Donor reimbursable expenses - Donor Agency fees - Legal fees 	<p>\$12,000 to \$15,000</p>
<p>SURROGACY AGENCY</p> <ul style="list-style-type: none"> - Consulting - Receipt Management Fees 	<p>\$15,000 to \$17,000</p>

<p>SURROGATE'S CAPPED REIMBURSABLE EXPENSES</p> <p>Variables:</p> <ul style="list-style-type: none"> - Experienced or not - Agency 	<p>\$20,000 to \$30,000 after pregnancy confirmed</p> <p>Additional Expenses</p> <ul style="list-style-type: none"> - Bedrest (variable) - Up to 6 weeks post birth net wage loss - Legal fees (\$1500) - Travel to clinic (see below)
<p>HEALTH INSURANCE FOR YOUR NEWBORN</p>	<p>\$5,200 base policy + possible additional \$3,300 if NICU required</p> <p>* Less than 25% of one day in NICU</p>

Item	Approximate Cost in CDN Dollars
<p>SURROGATE TRAVEL</p> <ul style="list-style-type: none"> - Screening Appointments - Transfers - Assumes purchase of travel medical insurance - Assumes companion travel (requirement for partners to be screened) 	<p>If flights required \$2,500 to 5,000 per trip</p> <p>If flights not required considerably less</p>

Item	Approximate Cost in CDN Dollars
<p>MISCELLANEOUS</p> <ul style="list-style-type: none"> - Life Insurance - Will - Maternity clothes 	<p>\$600 per year \$1,000 \$750 allowance</p>
<p>LEGAL FEES</p> <p>Always ask your lawyer about fixed fee guarantees – if the first contract fails will they do the second at no cost?</p> <p>Does their fee include staying involved throughout the process?</p>	<p>Surrogacy Contract: \$3,500 Surrogate's Lawyer: \$1,500</p> <p>Egg Donation Contract: \$1,750 split between two lawyers</p> <p>Parentage Process: \$2,500 to \$5,000 (depends on whether Court Order required and province in which baby is born)</p>

Item	Approximate Cost in Canadian Dollars
WORST CASE <ul style="list-style-type: none"> - C-section - Twins - Loss of reproductive organs 	\$2,000 - \$3,500 per event
YOUR CANADIAN TRAVEL	Variable
ACCOMMODATION IN CANADA	21 – 27 days assuming healthy baby
